Any defects in materials and/or workmanship will be repaired or replaced at our option, F.O.B. our plant, or at our option, in the field under straight-time conditions. All warranty work performed on Strobic Air's behalf must be authorized, on a written purchase order basis, prior to performing the work. Correction of defects by repairing or replacing shall constitute the fulfillment of Strobic Air's warranty. Strobic Air shall, in no event, be responsible for special, indirect, or consequential damages; nor for repairs or replacements made by others without the written authorization of Strobic Air.
